

Terms & Conditions

1. Your contract with CAMRA's Good Beer Tastings (GBT)

The client accepts the terms and conditions at the time of payment. Your booking is not secured until payment is received. CAMRA's GBT reserves the right to decline any booking at their discretion.

2. Cancellations

- 28 calendar days before the event: 100% refund
- 14 calendar days before the event: 50% refund
- Less than 14 days before: no refund

In the event of 'no-shows' by some or all tasters, no refunds will be provided.

3. Changes by the client

Any changes to the original booking must be confirmed via email. Whilst every reasonable effort will be made to accommodate changes and additional requests, this cannot be guaranteed.

4. Late arrival

If the client is late arriving for the booking, CAMRA's GBT will endeavour to fulfil the booking but reserve the right to adapt the length of the session accordingly.

5. Event Changes and Postponement

CAMRA's GBT reserves the right to make changes to the beer tasting event, including but not limited to, the beer selection, venue, or schedule.

In the event of unforeseen circumstances, CAMRA's GBT may need to postpone or reschedule the event.

6. Force Majeure

In the event of circumstances beyond the control of CAMRA's GBT, such as acts of God, natural disasters, or other force majeure events, we may cancel or reschedule the event without liability.

7. Cancellation by us

CAMRA's GBT reserves the right to cancel an event in any circumstances but will endeavour to avoid this unless it is absolutely necessary. In the event of cancellation by us, there will be a full refund offered to the client or the opportunity to reschedule, circumstances permitting.

8. Liability

CAMRA's GBT is not liable for any injury, loss, or damage to participants or their belongings during the beer tasting event.

9. Participants and Age Restriction

All participants must be of legal drinking age.
Valid identification may be required to verify the age of participants.

10. Responsibility and Conduct

Participants are expected to drink responsibly, and any disruptive or inappropriate behaviour will not be tolerated.

We reserve the right to ask any person to leave an event if their behaviour is deemed unacceptable or disruptive to others.

11. Photography and Recording

Participants may be photographed or recorded during the event for promotional purposes. By participating, attendees consent to the use of their likeness in promotional materials.

12. Allergies and Dietary requirements

Participants are required to inform CAMRA's GBT of any allergies or dietary restrictions at least 14 days in advance of the tasting.

While efforts will be made to accommodate such requirements, CAMRA's GBT cannot guarantee the absence of allergens.

13. Feedback and Complaints

Participants are encouraged to provide feedback on the beer tasting service.

Any complaints or issues should be brought to the attention of the hosts during the event for prompt resolution.
